

## 2024 Bay Days Vendor Application Packet

The Bay Days Committee invites craft and demonstration vendors and non-profit organizations to join us Friday, July 12 through Sunday, July 14 for Silver Bay's annual Bay Days celebration. Vendor hours will be finalized at a later date. Spaces will be assigned by the Bay Days Committee beginning Friday morning at 10 a.m. Vendors arriving earlier than 10 a.m. on Friday are not guaranteed an earlier set up time.

Booths will be 10' by 10' and will require a \$50 weekend deposit. Vendors must supply their own table(s), chair(s), displays, cords, power, shelter, and any other equipment. If you are using a portable generator, Lake County will require you to have a Neutral-Ground Bonding Plug. Neutral-Ground Bonding Plugs are available to purchase on Amazon. The Bay Days Committee advises extra weight on your tent poles to plan for Lake Superior area windy conditions. Please plan for your tie-downs to stay within your assigned space.

Vendors are responsible for their own shelter and product security. Please be advised that vendors set up in a grassy area near the stage, kids' games, and food trucks, and driving on the grass is not permitted. Plan to carry or cart your supplies to and from the vendor fair. We apologize for any inconvenience this may cause.

The Bay Days Committee allows one vendor per direct sales company such as LipSense, Pampered Chef, Thirty One, Tupperware, etc. Your check will be returned if someone else registers before we receive your information. Please note that we do not hold spots for vendors from previous years.

Vendor is responsible for their own tax reporting. The State of Minnesota requires Bay Days to collect ST-19 forms from all vendors. The ST-19 form can be downloaded on the [MN Department of Revenue website](https://www.revenue.state.mn.us).
